3	Ministry of Labour <u>Updated Health & Safety Guidelines for Construction</u> • MOL has approved a "Working at Heights" course from Newfoundland.
4	Ministry of Transportation Extension of CVOR and Oversize/Overweight Permits MTO has extended the validity of Commercial Vehicle Operator's Registration (CVOR), annual oversize/overweight permits and semi-annual and annual vehicle inspections that expired on or after March 1, 2020. These will continue to remain valid and legal past the expiry date until further notice.

	As advised by MTO: We are offering an extension for both the safety of members of the public and staff to not have to attend a Service Ontario Centre. This is not an exemption. These fees are regulated under the HTA and are not negotiable. Therefore, the past fees are postponed, not waived.
